**ALL PAYMENTS ARE DUE BY TUITION DATE, which is the day of the month when your child started the Daycare.**

\*I hereby agree to comply with any and all the rules and regulations of Anmol Daycare regarding fees, attendance, health regulations, clothing and other items specified in the parent manual. I **am aware of the scheduled school holidays and know that I am responsible for any that fall on my child’s regularly contracted days.**

\*I understand that payment is due in full by the Tuition Date, defined above. If it is required that my account be turned over to a collection agency, or that legal action be taken to resolve my account, I shall be responsible for all collection and/or attorney fees that may be incurred by my delinquency.

\*I am aware that any change in Tuition Rate will involve 30 days notification to me.

**\*I agree to notify Anmol Daycare One Month in advance of my child’s withdrawal from the program or pay the difference.** If no advance notice is given, I will be charged for one month of tuition even though my child does not attend for that period.

\*I am aware that **withdrawal of Services** by **Anmol Daycare** for my child can occur with **10 days of notice** due to any of the following reasons:

- Failure to provide verification of child’s immunization form within thirty days of enrollment at the school.
- Failure to pay fees and penalties which have become delinquent.
- Situations when it becomes a safety issue for my child or other children. This includes any group activity that may be deemed inappropriate for my child or the group of children. Anmol Daycare also reserves the right to limit or prohibit any activity or service that is a safety hazard for the staff and children.
